COMPLETION OF PLACEMENTS

Raiden Resources Limited (**ASX:RDN**) (**Raiden**) confirms that Tranche 2 of the September placement as announced on 4 September and approved by Shareholder at the 2020 Annual General Meeting, has been completed. 35,714,143 fully paid ordinary shares were issued to raise the balance of \$250,000.

Raiden further confirms that 230,769,231 fully paid ordinary shares (placement shares) to raise \$3,000,000 and 13,846,154 fully paid ordinary shares to in lieu of cash fees, as approved by Shareholders at the 2020 Annual General Meeting has been completed.

VESTING AND LAPSING OF PERFORMANCE RIGHTS

Raiden advises that 10,000,000 Class A Performance Rights held by Directors and other eligible participants in the Company's Employee Incentive Plan (approved by shareholders at the Annual General Meeting on 29 November 2019) have vested and been converted into fully paid ordinary Company shares.

The Company also advises that 10,000,000 Class B Performance Rights that were issued to key management personnel, including Directors in November 2019 have lapsed as the vesting condition was not satisfied before the expiry date.

Following the conversion and lapse, Class C Performance Rights remain on issue:
