Dear Shareholder,

Invitation to Participate in Share Purchase Plan

On 14 April 2023, Battery Minerals Limited (ACN 152 071 095) (**Company**) announced a two-tranche placement of 428,552,632 fully paid ordinary shares (**Shares**) at a price of \$0.0038 per Share to institutional, professional and sophisticated investors and, subject to Shareholder approval, Directors to raise \$1,628,500 (**Placement**).

407,500,000 Shares under tranche 1 of the Placement (**Tranche 1 Placement Shares**) were issued under the Company's placement capacity pursuant to ASX Listing Rule 7.1 and 7.1A on 24 April 2023. 21,052,632 Shares are to be issued to Director participants to raise \$80,000, subject to Shareholder approval (**Tranche 2 Placement Shares**). The Tranche 2 Placement Shares to be issued to Directors pursuant to ASX Listing Rule 10.11, are subject to the receipt of Shareholder approval at the Annual General Meeting on 31 May 2023.

In order to provide Eligible Shareholders (defined below) with the ability to participate in the Company's capital raising activities, the Company is pleased to provide details of a Share Purchase Plan (**Plan**).

Under the Plan, Eligible Shareholders will have the opportunity to purchase up to \$30,000 worth of Shares at the same price as the Placement, irrespective of the size of their shareholding, without incurring brokerage or transaction costs.

The offer under the Plan (**Offer**) is intending to raise a maximum of \$500,000 on the terms and conditions (**Terms and Conditions**) contained in this letter. The Company may elect to accept additional subscriptions or alternatively close the Offer early and/or scale back applications.

As announced on 14 April 2023, subject to receipt of Shareholder approval at the upcoming annual general meeting of the Company's Shareholders (**Annual General Meeting**), the Company plans to consolidate its issued capital on a 1 for 30 basis (**Consolidation**). For the avoidance of doubt all issue prices and numbers of shares contained in this Plan are on a pre-Consolidation basis. The Consolidation is expected to complete post the issue of Shares under this Plan.

In addition, the Company intends to implement a Share sale for those Shareholders whose shareholding does not constitute a marketable parcel under the ASX Operating Rules (a "marketable parcel" is shareholding with a market value of at least \$500). Shareholders Eligible to Participate in the Plan

Participation under the Plan is optional and is available exclusively to shareholders of the Company who are registered as holders of Shares at 5:00pm (WST) on 13 April 2023 (**Record Date**) and whose registered address is in Australia or New Zealand (**Eligible Shareholders**).

Share Purchase Plan

The Plan entitles Eligible Shareholders, irrespective of the size of their shareholding, to purchase up to \$30,000 worth of Shares at an issue price of \$0.0038 (**Price**) being the same price as the Shares offered to sophisticated and professional investors under the Placement. The Price is a discount of 23.25% to \$0.00495 (being the volume weighted average market price (**VWAP**) for the Shares over the last five trading days on which sales in the Shares were recorded before the day on which the Plan was announced. The Company was granted a waiver from ASX to the extent necessary to permit the issue price of Shares (under the SPP) to be slightly under the 80% limit prescribed in the relevant exceptions to ASX Listing Rules 7.2 and 10.12.

Whilst the Company intends to raise \$500,000, the Company reserves the right to accept additional applications subject to shareholder demand and compliance with the ASX Listing Rules. In accordance with the ASX Listing Rules, the maximum number of Shares that can be issued under a share purchase plan is that amount equal to 30% of the Company's existing issued share capital. Accordingly, as at the date of this document the maximum number of Shares which will be issued under this Plan will be 1,007,082,703 (on a pre-Consolidation basis).

Depending on applications received, the Company may, in its absolute discretion, undertake a scale back so that not more than \$500,000 is raised under the Plan. Scale back decisions are made by the Board and are final.

The Plan will not be underwritten.

The directors of the Company who are Eligible Shareholders reserve the right to participate under the Plan.

An application form for the Plan (**Application Form**) is included in this package.

Current Activities

The funds raised under the Plan and the Placement will be applied towards ongoing exploration on the Company's Stavely-Stawell Project and general working capital.

The number of Shares to which you are entitled will be calculated by dividing the subscription amount you have elected by the Price, rounded down.

By making an Application under this Offer and applying for Shares under the Plan, each Eligible Shareholder will be acknowledging that although the Price is at a discount, Shares are a speculative investment and the price of Shares on ASX may change between the date of the Company announcing its intention to make an Offer and the date of issue of Shares under that Offer and that the value of the Shares received under the Plan may rise or fall accordingly.

Additional Information and Important Dates

The offer of Shares under the Plan is made in accordance with ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547 and therefore does not require a prospectus for the purposes of Chapter 6D of the *Corporations Act 2001* (Cth) (**Corporations Act**).

The Offer cannot be transferred, and the Directors of the Company reserve the right in their absolute discretion to reject, or scale back, on an equitable basis, any Application. Shares issued under the Plan will be issued no more than five business days after the Closing Date of the Offer. Application for quotation on ASX of the new Shares will be made immediately following the issue of those Shares.

The maximum amount proposed to be raised under the Offer is \$500,000. The Company, however, reserves absolute discretion regarding the final amount raised under the Offer, subject to the ASX Listing Rules.

Post Annual General Meeting, assuming all resolutions are passed the Company will have capacity to issue 511,051,220 Shares under its ASX Listing Rule 7.1 capacity and 340,700,814 Shares under its ASX Listing Rule 7.1A capacity (on a pre-Consolidation basis). Where the shortfall exceeds the Company's placement capacity, the shortfall will only be placed if shareholder approval is obtained.

Share Purchase Plan - Terms and Conditions
Purpose

The purpose of the Share Purchase Plan (**the Plan**), which will be conducted in conjunction with the Placement, is to offer shareholders of Battery Minerals Limited (**Company**) the opportunity to acquire additional fully paid ordinary shares in the Company (**Shares**) up to a maximum of \$30,000 (when combined with any shares issued under any share purchase plan in the 12 months preceding the date of the Plan) and a minimum of \$2,000 worth of Shares.

The issue price of \$0.0038 under the Plan will be at a discount of 23.25% to the volume weighted average market price for Shares over the last five trading days on which sales in the Shares were recorded prior to the date the Plan was announced. The Company was granted a waiver from ASX to the extent necessary to permit the issue price of Shares (under the SPP) to be slightly under the 80% limit prescribed in the relevant exceptions to ASX Listing Rules 7.2 and 10.12.

The Company is intending to raise \$500,000 under the Plan. The Shares will not attract brokerage costs and will be issued without the need for the Company to issue a prospectus. The Plan is governed upon such terms and conditions as the board of directors of the Company, in its absolute discretion, sees fit.

As announced on 14 April 2023, subject to receipt of Shareholder approval at the Annual General Meeting, the Company plans to consolidate its issued capital on a 1 for 30 basis (**Consolidation**). All references to Shares and issue prices in this Plan are on a pre-Consolidation basis.
