8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
Answer: No. During the December 2022 Quarter the Company continued to initiate overhead cost-cutting efforts. Major exploration activities have also been temporarily ceased until completion of the sale of Mozambique assets to Tirupati Graphite plc. As a result, the Company expects its cash operating cash flows to be approximately \$650,000 for the next quarter.	
8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
Answer: The Company expects to complete the sale of its Mozambique assets to Tirupati Graphite plc, subject to Mozambican government approval during the March 2023 Quarter which will inject \$1.5 million in cash into the Company, as well as share consideration to the value of up to \$11 million. \$0.5 million in partial consideration was received on 27 January 2023.	

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes. As set out in the answers to Questions 8.8.1 and 8.8.2 above, the Company anticipates having circa \$2.2 million in cash (made up of its existing cash at 31 December 2022 of ~\$0.7mil, and \$1.5 million in cash from the sale of its Mozambique assets) to fund to the Company's activities.
